## **PAYMENT TERMS AND CONDITIONS OF USE**

The Thompson Regional Airport is operated by the Thompson Regional Airport Authority. The Authority has duly imposed the fees for the use of the services and facilities described in this schedule.

All fees do not include Canadian Goods and Services Taxes, which must be collected from the customer in addition to any fees payable for use of services.

All fees described in this schedule will be invoiced weekly or monthly, in arrears. Customers will have 30 days from the invoice date to pay the Authority all invoiced fees. Outstanding amounts will be charged 3% above the prime rate from the respective due date and compounded monthly.

Fees in this schedule will become effective June 1<sup>st</sup>, 2017.

## Operating Fees – Thompson Regional Airport Authority

### Terminal Usage Fees

For use of the main Terminal Building prior to aircraft enplaned; based on seating capacity of the aircraft, charged per terminal departure.

### Aircraft Related Fees

#### Landing Fees

Landing fees are charged per 1,000 KG or portion thereof the maximum design takeoff weight (MTOW) of the aircraft, subject to a minimum fee of \$18.34. No landing fee is payable if an aircraft is required to return to the airport and land due to a mechanical or medical emergency. Training is assessed at 80% of the cost.

#### Regulatory Fees

Safety and security regulatory fees are collected on commercially registered aircraft and charged per landing.

<i>Fee</i>	<i>Charge per landing</i>
Security regulatory fee	\$15.00
SMS regulatory fee	\$10.00

*Aircraft Parking Fees*

Daily fees are based on the maximum design takeoff weight (MTOW) of the aircraft and are assessed after 2 hours of parking. A monthly fee of \$87.93 is charged on privately registered aircraft only. Some electrical plug-in services are available for an additional fee of \$6.60 per day.

**Car Parking Fees**

Car parking fees is based on daily or monthly usage. The Airport is not responsible for theft or damages incurred when parked.

**Other Airport Operating Fees**

Taxi Permits	\$171.76 per year
Advertising - back-lit signs	\$72.02 per month
Locker Rentals (deposit required)	\$10.00 per month

Terminal lease	\$35.61 square meter/per month

**Airport Improvement Fees (AIF) – Thompson Regional Airport Authority**

An AIF in the amount of **\$30.00 per departing passenger** originating from the Thompson Airport is payable from signatories as per conditions set out in the memorandum of agreement.

Non-signatories, Freight, and Medivac aircraft departures are charged per 1,000 KG or portion thereof the maximum design takeoff weight (MTOW) of the aircraft, with a **minimum AIF of \$30.00**.
